CHABLIS I Z 2009 BREEDING CONTRACT

I hereby agree to breed my mare, Named: _____
Breed: _____ Age: _____, Reg. Number: _____
to the Holstein stallion **CHABLIS I Z**, Registration Number: 21000286202, Approved by the Zangersheide Studbook & CSHA, in the 2009 breeding season for a breeding fee of \$1,500.00 +GST, or \$1,300.00 +gst, if booked before March 31/09. A booking fee of \$300.00+GST is included in the breeding fee and is due upon signing of this contract. **The balance of the breeding fee is then due before the first shipment of semen is needed. A credit card MUST be supplied at the time of contract signing to cover all expenses related to this breeding, i.e. container, shipping and collection fees (if applicable).**

The booking fee entitles the mare owner one- (1) shipment of semen per breeding cycle. **If further semen is required during the same cycle a collection fee of \$150.00+GST will be charged to the mare owner per shipment.** If said mare does not conceive, then one (1) shipment of semen will be sent without collection fees for each consecutive cycle, within the same breeding season, until conception. Shipping and container fees will be billed at the time of the shipment and charged to the credit card provided.

Should said mare be coming to Ashland Farm, for on farm breeding, the mare owner is required to provide a negative cervical culture certificate, a negative Coggins test and proof of yearly vaccinations, before or upon delivery. Daily mare care fees are \$20.00+GST per day, or \$25.00 +GST per day, with a foal, and includes handling, stall, bedding, and feed. All veterinary expenses will be billed directly to the mare owner by the vet.

It is agreed that should the mare miscarry or abort after confirmation of pregnancy, the mare owner has the privilege of re-breeding. Satisfactory evidence of proper care and veterinary attention given to the said mare must be provided. **If the re-breeding were to be held over to the following breeding season (2010), the booking fee of \$300.00 +GST, would be due prior to the first semen shipment.**

It is agreed to have your mare checked for normal breeding conditions, and to perform other veterinary service deemed necessary, at owner's expense. This includes and is not limited to, palpation, treating for infection, pregnancy testing, etc.

It is further agreed that should either CHABLIS I Z or the above noted mare die, be sold, or become unfit for service, this contract is eligible to be transferred to another mare or stallion. Any transfers must be done in writing to the stallion owner/manager.

Ashland Farm and any employees or volunteers shall not be liable for any disease, accident or injury to your mare and you shall not be held liable for any disease, accident, or injury to the stallion.

This contract shall be binding upon both of us, when accepted by you. This contract is not transferable.
